### **Interoperability Demo to Set Up and Showcase a Trusted Environment**

NCOIC is holding a real-time interoperability demonstration that will allow member-companies to show their capabilities and underscore the benefits to organizations in collaborating via an interoperable network environment. A secure federated-cloud infrastructure will be used to demonstrate a disaster-response scenario and highlight the consortium's work in how to develop a trusted environment, including governance processes, federation management and interoperability verification.



The event will be held in November or December at the Gannett Headquarters in McLean, Virginia, in conjunction with the quarterly Advisory Council and Board of Directors meeting. The day will also include a vendor display area where participants can present their products, services, concepts and other interoperability enablers. ### **Contracting Study Results Shared with NCI Agency**

Thanks to all members who participated in the “quick response” study that NCOIC is completing for the NATO Communications and Information Agency. The information collected on acquisition best practices, processes and guidelines used by large organizations to address small-value contracts was shared with the NCI Agency at a workshop in Brussels on September 12-14. Results of the "NCI Agency External Customer Support Model (ECSM) Adaptation Study" and the consortium's recommendations are being reviewed by the NCI Agency as it looks for ways to use industry customer-support models to improve the delivery of C3 systems and ICT services to external customers, while meeting the demands of its primary customers and core business. The study and workshop are part of a multi-phase effort designed to assist the agency in adapting its external customer support model to expedite product/service delivery that are funded by a NATO nation or external organization and within NATO needs.
